Submission Options

An Amendment to the Certificate of Limited Partnership may be filed using one of the following methods:

Paper submission: A blank Amendment to the Certificate of Limited Partnership may be obtained by going to sos.tn.gov and entering SS-4471 in the search bar; by emailing the Secretary of State at TNSOS.CORPINFO@tn.gov, or by calling (615)741-2286. The Amendment to the Certificate of Limited Partnership should be typed or hand printed in dark blue or black ink.

Walk-in: A blank Amendment to the Certificate of Limited Partnership form may be obtained in person at the address listed below.

If submitting by mail, send the completed form and filing fee together in the same envelope. Mail to:

Completing the Form

The Amendment to the Certificate of Limited Partnership provisions are set forth in the Tennessee Uniform Limited Partnership Act of 2017, T.C.A. § 61-3-202 or the Tennessee Revised Uniform Limited Partnership Act of 1988, T.C.A. § Section 61-2-202.

1. **Control Number:** Enter the control number assigned to the Limited Partnership. To find entity information, including the Secretary of State control number, visit:

2. **Limited Partnership Name:** Enter the exact, legal name of the Limited Partnership as listed on the records of the Tennessee Secretary of State. To find entity information, including the exact, legal name, visit: <https://tnbear.tn.gov/ECommerce/FilingSearch.aspx>.
3. **Amendment to the certificate:** Enter the amendment that the partnership has agreed to amend on the certificate.
4. **Effective date:** If the effective date is not to be the date of filing by the Secretary of State, enter the delayed date and time. A delayed date may not be later than ninety (90) calendar days from the filing of this Amendment to the Certificate of the Limited Partnership.
5. **This Limited Partnership elects to be governed by the Tennessee Uniform Limited Partnership Act of 2017:** By checking this box, the signer certifies that the partnership has approved in record in accordance with T.C.A. § 61-3-1207(b)(1) to be governed by the Tennessee Uniform Limited Partnership Act of 2017.

Signature

The amendment must be signed and dated by at least one general partner and any new general partners added by this amendment. Type or print the signature name and enter the capacity that the signer has to sign for the partnership. Failure to do this will result in the form being rejected.

Filing Fee

The filing fee is \$20.00 per Amendment to the Certificate of the Limited Partnership.

Make check, cashier's check or money order payable to the Tennessee Secretary of State. Cash is only accepted for walk-in filings. Forms submitted without the proper filing fee or made payable to an entity other than the Tennessee Secretary of State will be rejected.
