Submission Options

A Statement of Termination of Limited Partnership may be filed using one of the following methods:

E-file: Go to <https://tnbear.tn.gov/Ecommerce/FilingSearch.aspx> and use the online tool to complete the filing and pay the filing fee by credit card or debit card. When paying by credit/debit card, there is a service fee charged to the customer. Filers who do not wish to pay the service fee to file online may choose the "Print and Mail, Paper Submission or Walk-In" option at no additional cost.

Print and Mail: Go to <https://tnbear.tn.gov/Ecommerce/FilingSearch.aspx> and use the online tool to complete the termination. Print and mail the completed Statement of Termination along with the required filing fee to the address listed below.

Paper submission: A blank Statement of Termination of Limited Partnership form may be obtained by going to sos.tn.gov and entering SS-9420 in the search bar; by emailing the Secretary of State at TNSOS.CORPINFO@tn.gov, or by calling 615-741-2286. The Statement of Termination of Limited Partnership should be typed or hand printed in dark blue or black ink.

Walk-in: A blank Statement of Termination of Limited Partnership may be obtained in person at the address listed below.

If submitting by mail, send the completed form and filing fee together in the same envelope. Mail to:

Completing the Form

Pursuant to T.C.A. § 61-3-803, enter the following information:

1. **Control Number:** Enter the control number for the Limited Partnership. To find entity information, including the Secretary of State Control Number, visit:

2. **Limited Partnership Name:** Enter the exact legal name of the Limited Partnership. To find entity information, including the exact legal name, visit:
<https://tnbear.tn.gov/ECommerce/FilingSearch.aspx>.
3. **The above Limited Partnership is terminated.** By signing this form, you confirm that this Limited Partnership has been terminated.

Prior to accepting the filing, the Division of Business Services will request a Certificate of Tax Clearance for purposes of termination from the Tennessee Department of Revenue. If the tax clearance cannot be obtained, this document will be rejected and returned to the applicant.

A Statement of Dissolution must be filed before, or at the same time the Statement of Termination is filed. If the Statement of Dissolution has a delayed effective date, the Statement of Termination cannot be submitted until such effective date.

Signature

The Statement of Termination must be signed and dated by all general partners listed in the Certificate of Limited Partnership. Type or print the signature name and title of each signer. Failure to do so will result in the application being rejected.

Filing Fee

The filing fee is \$20.00.

Make check, cashier's check or money order payable to the Tennessee Secretary of State. Cash is only accepted for walk-in filings. Forms submitted without the required Certificate of Tax Clearance for Termination, the proper filing fee, or made payable to an entity other than the Tennessee Secretary of State will be rejected.
