Submission Options

An Application for Name Reservation may be filed using one of the following methods:

Paper submission: A blank Application for Name Reservation may be obtained by going to sos.tn.gov and entering SS-9425 in the search bar; by emailing the Secretary of State at TNSOS.CORPINFO@tn.gov, or by calling (615)741-2286. The Application for Name Reservation should be typed or hand printed in dark blue or black ink.

Walk-in: A blank Application for Name Reservation may be obtained in person at the address listed below.

If submitting by mail, send the completed application and filing fee together in the same envelope. Mail to:

Completing the Application

This Application does **not** need to be filed with an initial filing (charter, articles of organization, registration, etc.).

1. **Please check the appropriate box:** Select the correct box for the statute under which you are filing the name reservation.
2. **The undersigned hereby applies for reservation of the following name for a period of 120 days:** Enter the name you want to reserve. The name must meet the name distinguishability requirements and any other requirements outlined in these statutes:

The name of a corporation must meet the requirements of T.C.A. § 48-14-101 (For Profit Corporation) or T.C.A. § 48-54-101 (Nonprofit Corporation).

The name of a Limited Liability Company must meet the requirements of T.C.A. § 48-207-101 or T.C.A. § 48-249-106.

The name of a Limited Liability Partnership must meet the requirements of T.C.A. § 61-1-1003.

The name of a Limited Partnership must meet the requirements of T.C.A. § 61-3-112 or T.C.A. § 61-2-102.

3. **Applicant name & address:** Enter the name and address of the applicant. Include street address, city, state and zip code.

Signature

Enter the date and signature. Print or type the signature name and the signer's capacity to sign on behalf of the company, if other than individual capacity. Failure to do any of these will result in the form being rejected.

Filing Fee

The filing fee is \$20.00 per Application for Name Reservation.

Make the check, cashier's check or money order payable to the Tennessee Secretary of State. Cash is only accepted for walk-in filings. Requests submitted without the proper filing fee or made payable to an entity other than the Tennessee Secretary of State will be rejected.
